- o November 12th, 2024
 - 1st motion by Elam to accept the minutes as written, 2nd by Gaubert. No further discussion. All in favor.
- New Business
 1708 Hall
 - o Received nominations and take desired action(s) to elect the Local Board of Fire Control officers for 2025.
 - Chair, Secretary and Treasurer
 - The board held discussion related to the officer positions and expectations. 1st motion made by Hall is elect Cliff Gaubert as Chair, Hal Hall as Secretary, and Tommy Bulman as Treasurer to serve within the roles until the first regular business meeting of 2026. 2nd by Gaubert. No additional discussion. All in favor.
 - Receive information and take desired action related to district impacts caused by the Winter Storm on January 10 – 11, 2025.
 - Chief Eubanks provided remarks related to the event. No large impacts were noted. The district utilized off-duty personnel to upstaff during the event.
- Old Business
 1711 Hall
 - Receive information updates and take desired action related to the March 25, 2025, referendum.
 - Chief Eubanks provided an update on the upcoming referendum set for March 25, 2025. Legal public notice is set for January 17, 2025, in the Spartanburg Herald Journal. Referendum information will also be available on the district's website at ssfire.org. Chief Eubanks will continue to work with Pope Flynn Firm to create a FAQ sheet for information purposes for public distribution. Once completed the FAQ sheet will be added to the district's website.
 - Receive information updates and take desired action related to projects and anticipated expenses defined within the supplemental funding request as approved through the SC FY24/25 Appropriation Act.

- At 1728, Chief Smith provided a report related to the supplemental funding projects. Several projects are underway including the addition of an SCBA compressor and fill station to Arkwright station, the addition of diesel exhaust filtration system at Arkwright Station, remodeling and addition of a ADA community space on the main level of Croft Station, and the addition of 14 new SCBA for the fleet.
- Receive information updates and take desired action related to district impacts caused by Hurricane Helene.
 - At 1745, Chief Smith provided a report to the board related to the expenses incurred during Hurricane Helene and the days following. Chief Smith has been working closely with FEMA to complete the needed paperwork and to provide supporting documentation to seek funds to offset our expenses. This process should close within a few weeks.

 - Chief Eubanks reported that the district has one vacancy within the operations division. The Fire Marshals office conducted 27 business inspections and reported 242 discrepancies during Nov/Dec 2024. No grants were received for the period.
- Personnel Development
 - Chief Long reported that the district's personnel had engaged in 2,566 hours during the Nov/Dec 2024
- Operations
 - Chief Eubanks reported that Squad 27 is out of service awaiting brake parts. Capt. Crook reported that during Nov/Dec 2024, the district was involved in 15 community events and came in contact with 326 individuals.
